1. Introduction

2. Scope of Services

MHI intends to distribute 800 chickens, along with materials and medicines, to 40 families as part of the poultry project in Kabul, Afghanistan. If you are interested and available within the specified time and location, please submit your bid.

- 1- The cost includes the purchase of 15 items, applicable taxes, loading and unloading fees, distribution of poultry expenses, and transportation costs to the targeted areas of Deh Dana and Sar Asyab in Districts 6 and 7 of Kabul Province.
- 2- The transportation of poultry, materials, and medicine, as well as the distribution of poultry to the designated location, will be the responsibility of the supplier.
- 3- Supplier will stay at the place until the distribution is ended.
- 4- The supplier should ensure that the procured poultry, materials, and medicines match the approved samples in terms of quality, quantity, and specifications.
- 5- The supplier should be responsible for the safe and timely transportation of the poultry and other materials to the designated delivery location.
- 6- The supplier should provide a certificate confirming that the poultry feed outlined in the RFQ contains the specified amount of protein and moisture.
- 7- **The expected delivery date is one week after the contract is awarded to the successful bidder.**

The eligibility of Supplier that are wholly or partly owned by the Government shall be subject to MHI's further evaluation and review of various factors such as being registered, operated and managed as an independent business entity, the extent of Government ownership/share, receipt of subsidies, mandate and access to information in relation to this RFQ, among others. Conditions that may lead to undue advantage against other Bidders may result in the eventual rejection of the RFQ.

5. Does the supplier have the same experience with other NGOs or institutions? If so, please list the NGOs/institutions and indicate if we may contact them.
6. Does the RFQ adequately describe in a clear concise, and understandable manner the work to be performed including **sampling** techniques and analytical procedures to be used?
