Roots of Peace (ROP), the implementer of the UNDP-funded CBARD projects, invites qualified vendors to submit quotations for the Provision of Seeds, Equipment, and installation of Plastic Covering sheets for Greenhouses in Farah and Badghis Provinces.

<b>Anticipated Award Type</b>	ROP anticipates issuing a <b>Firm Fixed Price Purchase Order</b> . This is only the anticipated type of award and may be changed as a result of negotiations.  Issuance of this RFQ in no way obligates ROP to award a subcontract or purchase order and Bidders will not be reimbursed for any costs associated with the preparation of their quote.
<b>Basis for Award</b>	Lowest Price Technically Acceptable (LPTA).
<b>Delivery Terms</b>	Delivery at Place. The province location is provided in the Technical Specification section. The exact addresses will be provided upon award.
<b>Expected delivery date</b>	Within 30 calendar days from the issuance of the Purchase Order (PO). The bidder shall be expected to provide a realistic delivery time. Bidders providing a realistic shorter delivery time shall be preferred for this solicitation.
<b>Documents to be submitted</b>	<b>The bidder must specify all the required parameters listed in the “Technical Specifications” section. Failure to do so may disadvantage the bid during the evaluation process.</b>  Offerors should submit all documents as outlined in the quotation Checklist (Annex 6).
<b>Payment Terms</b>	The bidder understands and agrees to ROP payment terms, the payment will be in Afghani at the exchange rate on the date of wire transfer of the recipient bank. Payment will be made by bank-to-bank wire transfer to your official company. The payment will be made after the successful completion of the services as provided for in the award, and within 60 days of receipt of an acceptable invoice. Any applicable exchange rate is applied by the recipient’s bank at the time of a wire transfer and is outside of the control of ROP/CBARD.

<b>Tax</b>	<p>Any vendor contracted to supply Goods, Works or Services should hold an appropriate valid business license throughout implementation of a contract. Implementation meaning from the moment of the fully executed contract through to the delivery, installation, and acceptance of Goods, Works or Services. If a vendor's license expires before implementing the award, a tax withholding of 7% shall be applied for the value of the entire award irrespective of when the business license expires. If a vendor does not hold a business license, then 7% tax withholding will apply automatically.</p> <p>A vendor will be offered the opportunity to renew the appropriate business license, and, in such cases, payments shall be withheld by ROP for a period of ten working days. However, if the vendor elects not to renew a license, or a period of ten has expired, ROP shall withhold 7% for tax purposes, and make payment.</p>

## 2. INFORMATION TO BIDDERS

### 1. Background

Roots of Peace (ROP) is a humanitarian organization whose mission is to rid the world of landmines and other remnants of war by transforming toxic minefields into thriving farmland and communities through a focus on sustainable, organic farming practices. Roots of Peace is implementing a Community-Based Agriculture Rural Development (CBARD) project to support the Production of Fruits and Vegetables as an alternative to poppy Cultivation and Trade in five high Cultivation provinces of Afghanistan.

Moreover, the ROP-CBARD project aims to create partnerships between existing ROP-CBARD communities to reach three key objectives: reducing opium poppy cultivation, creating alternative licit economic development for former poppy farmers and women in the community, and supporting more sustainable peace.

3. Liquidated Damages	<p>Except under the circumstances of Force Majeure, if the Contractor fails to deliver any or all the goods by the date(s) of delivery or perform the services tied to the delivery of goods within the period specified in the Contract, ROP may, without prejudice to any or all its other remedies under the Contract, deduct 15% of the total contract value which will be applied on the 41st day. Thereafter a further 15% of the total contract value to be applied on the 51st day and thereafter every seven days until the vendor completes his contractual obligations.</p>

## 4. EVALUATION AND AWARD

An award will be made based on the Lowest Price, Technically Acceptable source selection process. The award will be issued to the responsible Offeror submitting the lowest evaluated price that follows the RFQ instructions and meets or exceeds the acceptability requirements for technical requirements described in this RFQ. All received bids will be evaluated based on the initial minimum criteria below. Vendors who do not pass will be removed from consideration.

ROP-CBARD will evaluate the following factors as PASS/FAIL:

- **Technical Specification - the goods offered meet or exceed the RFQ requirements.**
- **Submission of current and valid MOCI License.**
- **Submission of Banking / Payment information. (Only AFN Accounts will be accepted)**
- **At least two successful contracts have been completed in the last five years in providing Greenhouse equipment such as Seeds, Seed Tray, NPK fertilizer, Peat moss etc. It's a requirement to attach the copies of relevant past contracts as evidence.**
- **Certification to certify that that the offered seeds are from a valid original source. Companies that will not submit this certification shall be disqualified from further evaluation.**

Vendors who pass the initial screening based upon the criteria above will proceed to the Lowest Price Technically Acceptable evaluation to determine the successful offer. ROP reserves the right to increase and or decrease the requirement during the evaluation and or award stage. The ROP reserves the right to conduct sample check during the evaluation. All goods shall be high quality products, low quality products will not be accepted. ROP reserved the right to award the contract lot wised and or items wised.
