Save the Children began its program in Afghanistan in 1976. Over the last few years, Save the Children's programs expanded to 10 provinces in the country. Save the Children's programs in Afghanistan are guided by the awareness that the disparities in Afghani society are rooted in the historical exclusion of a majority of social groups, mainly children and women, Save the Children actively seeks to empower such groups through its programs.

**I. PURPOSE OF EOI:**

SC invites Expression of Interest (EOI) from qualified organizations, women led preferred, to implement programs in Nutrition, FSL and WASH with Protection mainstreaming/MHPSS in Jawzjan province

**II. APPLICANTS ELIGIBILITY CRITERIA**

Criteria for the organizations to be considered as potential partner include:

- Women-led organizations with a humanitarian mandate and/or mission that is governed/directed by women or whose leadership is principally made up of women (demonstrated by 50 per cent or more occupying senior leadership positions). (preferred)
- The organization should have established office in Jawzjan Province (required)
- Organization should be registered according to prevailing laws and regulations (required)
- Organization should have technical knowledge, past experience in livelihood, WASH, Nutrition projects (required)

**III. Required Supporting Documents:**

1. Legal status of the organization (Organization Registration Certificate)
2. Organization profile (including specific mandate and value addition in service delivery, size of the organization, % of women in leadership, geographical scope, office premises, technical knowledge, past experience (in livelihood, WASH, Nutrition projects))

3. List of board members including senior leadership in Kabul and Jawzjan province
4. Recent Audit report
5. List of current projects along with the operational locations
